The Committee discussed levels of transparency with the regard to the Special Purposes Committee itself, and agreed that every reasonable measure, including publication of Committee minutes, and Reports to Council, had already been taken to achieve this. The Committee will keep this area under review as it continues to develop its advisory role both to the President and to the Council.

Regarding the Regulated Professions (Health and Social Care) (Amendment) Act 2020, the Registrar clarified that discussions with PSI legal advisers were ongoing in relation to the application of the relevant amendments.
