Agenda Item E. Request for approval from Council for Delegation to the Registrar

Issue

Request to approve a delegation to the Registrar under Sections 56(4) of the Pharmacy Act 2007 as inserted by section 70 (d) of the Regulated Professions (Health and Social Care) (Amendment) Act 2020

Information

Council was advised that this delegation relates to a new power arising under the amendment to the Pharmacy Act 2007 by the Regulated Professions (Health & Social Care) (Amendment Act) 2020 and is, therefore, a new delegation for Council. Council was asked to approve a motion to delegate to the Registrar the power to notify regulatory bodies in other jurisdictions of any sanction imposed by the Council on a registrant together with documentation relevant to that sanction, where it has come to the Council's attention that that registrant may also be registered in that jurisdiction and the sanction may not have come to the attention of the regulatory body in that jurisdiction.

Agenda Item F – Falsified Medicines Directive (FMD) Update

Mr. John Bryan, Head of Community Pharmacy Assurance, and Ms. Éilis Crimmins, Quality and Safety Manager (Community Pharmacy), updated Council on the work being done by the PSI in relation to the implementation of the Falsified Medicines Directive.

Information

Council queried how the exact percentage of decommissioning in each pharmacy could be ascertained. The Executive informed Council that it would be difficult to establish a precise percentage figure for each pharmacy, as the number of items dispensed in each pharmacy would not be known; however, as a general rule, scanning levels should match, or be close to, the total figure of medicines dispensed and logged in the daily audit for each pharmacy. Council queried if the PSI intended to inspect hospital pharmacies to ensure FMD compliance. The Executive informed Council that it intended to monitor registered retail pharmacy businesses in hospital settings for FMD compliance.
